

TIMBER PRODUCTS OUTPUT AND USE

2021 Mississippi Wood Flow Analysis

Mississippi forests accounted for a total of 935,410 thousand cubic feet (MCF) of timber products while the forest products industry produced a total of 670,074 MCF within the State.

This resource update presents estimates of wood flow derived from the findings of an annual survey conducted on a sample of all primary wood-using mills in Mississippi and complements the Timber Products Output factsheets providing additional summarized roundwood data. The annual survey was conducted to determine the amount and source of wood receipts and timber product imports/exports. Data used in this update were accessed from the FIA Timber Product Output database (page 3).

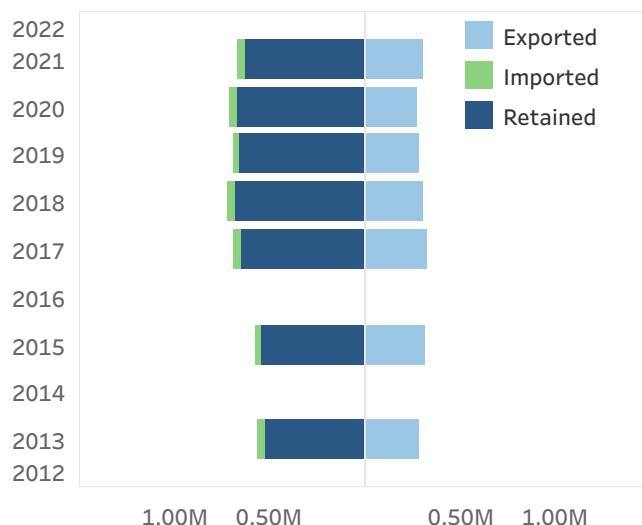


Mississippi retained 628,935 MCF and exported 306,475 MCF out of State for a total production of 935,410 MCF.



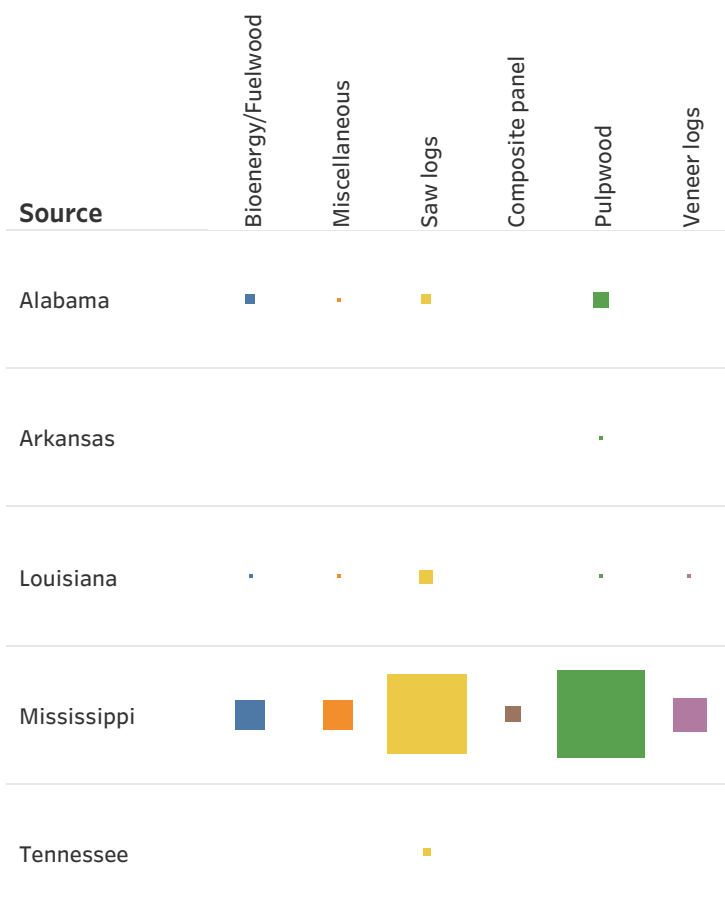
Mississippi retained 628,935 MCF and imported 41,139 MCF from other States for total receipts of 670,074 MCF.

Wood Flow Volume (MCF)

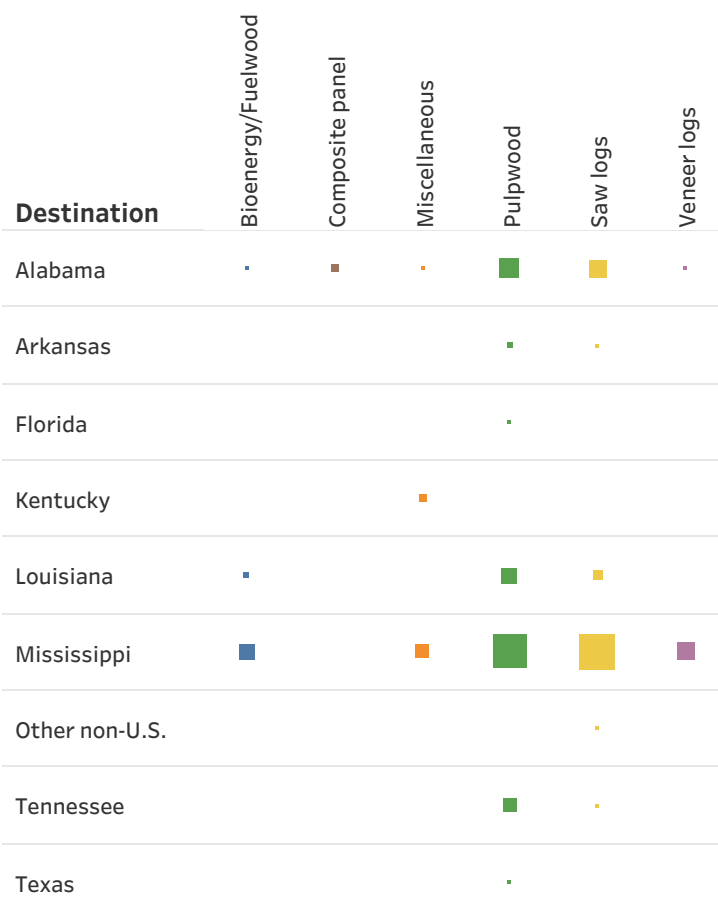


Wood Flow Volume (MCF) by Product

Production (Retained and Exported Wood)

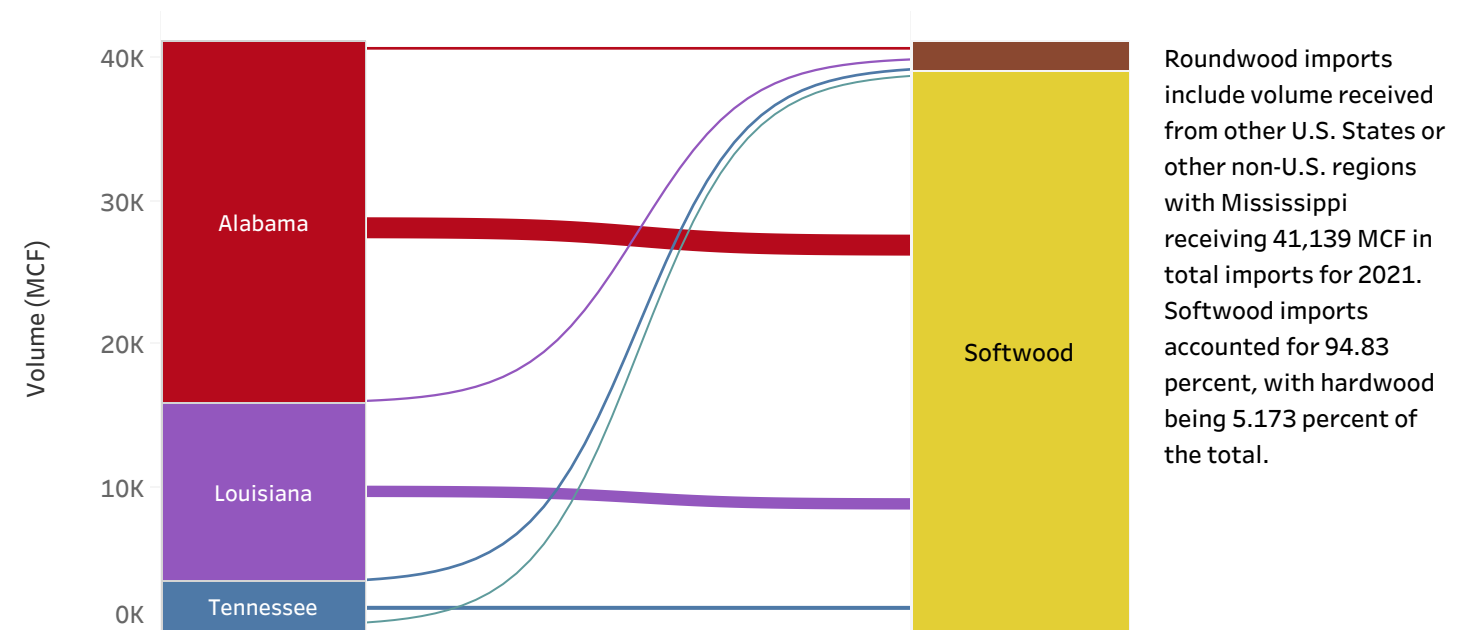


Receipts (Retained and Imported Wood)



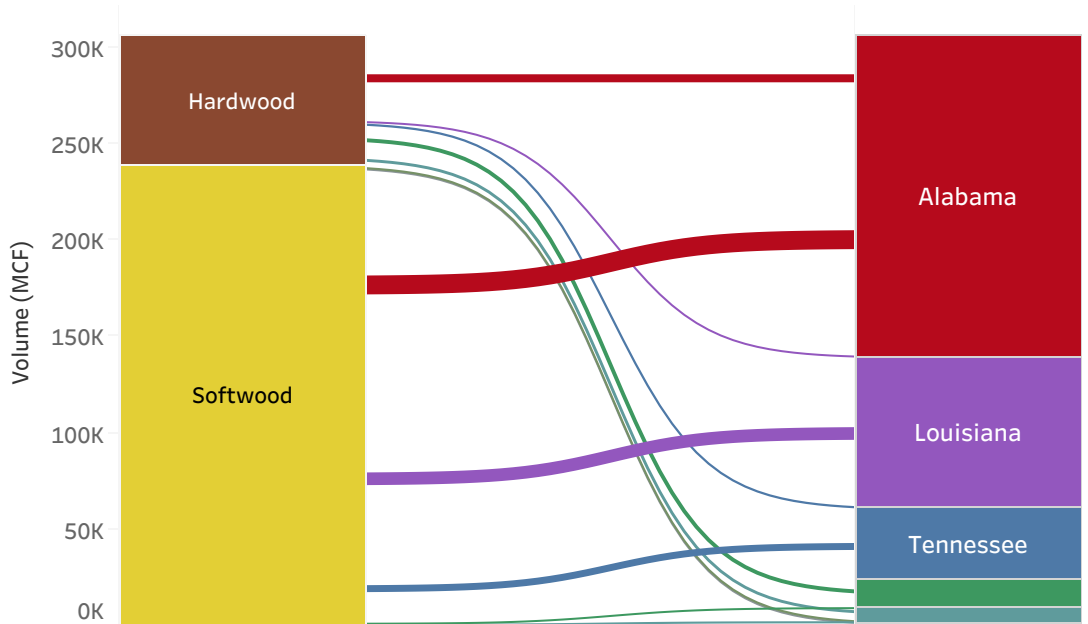
In 2021, Mississippi was a Net Exporter

Roundwood exports include volume transported to other U.S. States or other non-U.S. regions with Mississippi transporting 306,475 MCF in total exports for 2021. Softwood exports accounted for 77.88 percent, with hardwood being 22.12 percent of the total.
